A Clause 3 (privacy) - complaint was upheld and newspaper required to publish correction under headline 'IPSO complaint upheld'.

01823-14 - Woman v Chester Leader (IPSO officer Bianca Strohmann)

Complaints about clause 1 (accuracy), clause 3 (privacy) and clause 5 (intrusion into grief/shock).

After protracted correspondence and negotiations, the newspaper offered to remove the article from its website and the offer was accepted.

The Complaints Committee did not make a determination.

03320-15 - Wrexham Leader (IPSO officer

'Victim pulled kitchen knife out of stomach' - February 24, 2015).

Complaints about clause 1 (accuracy), clause 3 (privacy) and clause 9 (reporting of crime).

The newspaper did not dispute there were inaccuracies in copy provided by a news agency and offered to apologise for them. The offer was not accepted by the complainant.

The Complaints Committee did not find in favour of the complainant and the complainant did not appeal against the committee's decision. The case file was closed.

Article 'Woman died after eating toast' - November 5, 2014.

Complaint about clause 1 (accuracy). Issue resolved and case file closed.
