CHAIRMAN

Five years ago, few would have believed that we would make such determined progress in establishing regulation as vital for protecting the public and maintaining freedom of expression. But I am confident that IPSO is now justified in making that claim. Standing at the boundary between protection of freedom of expression and the harm that may be caused by unregulated opinion and news, we cannot escape criticism from both the public and those we regulate. But that criticism merely shows how seriously they take our rulings and guidance.

Our achievements are due, in the main, to four features of IPSO: our administrators who daily engage with the public with patient concern; our complaints staff who stand up for the public; our independent vociferous Complaints Committee; our Board, far-seeing and canny, providing the right direction for progress.

In 2018 Martyn Lewis and Keith Perch, who had been with us since our inception, left our Board and Ian MacGregor, Martin Trepte and Matthew Lohn were appointed. Nina Wrightson, Gill Hudson, Neil Watts and David Jessel left our Complaints Committee and Helyn Mensah, David Hutton, Mark Payton and Andy Brennan were appointed.

The personalities may have changed but the qualities have not. They all set examples of independence of thought and decision, examples which have been whole-heartedly followed. As the renewal of five year contracts between IPSO and its regulated entities has just taken place, it is worth re-iterating that the public will be best protected by voluntary but binding agreements by which the press submit to regulation by IPSO. The past five years shows, beyond question, the importance of this as a framework for a free and vibrant press and protection for the public.

If this has a touch of retrospective pride and optimism for the future, I hope I may be forgiven because, a new Chair has been selected and I will leave at the end of 2019. What I am happy to have achieved is due entirely to the guidance of Chief Executive, Matt Tee; Director of Operations, Charlotte Dewar; Head of Standards, Charlotte Urwin; Heads of Complaints past and present, Bianca Strohmann, Ben Gallop, Holly Pick and Lauren Sloan; and Communications Manager, Vikki Julian – all of whom have given me direction and supported me throughout. I am more than grateful to them and to every one of those at IPSO who have served and continue to serve the public and the press. My confidence that under a new Chair we can, and will, do even better, is a tribute to them all.

CHIEF EXECUTIVE

Despite being wholly independent of government, events in Parliament can have an impact on us – and in 2018 issues around press regulation featured more than at any time since the Leveson report. The government announced that it would not undertake the second part of the Leveson Inquiry and would repeal Section 40 of the Crime and Courts Act, which would have enabled judges to award costs against newspapers not regulated by a recognised regulator, even if they won. They also saw off attempts to amend the Data Protection Bill which would have imposed these.

One of the key arguments used by ministers for this was that IPSO has proved its effectiveness and further measures are not necessary. This effectiveness was bolstered by national newspapers agreeing to be subject to a compulsory arbitration scheme (rather than a previous voluntary scheme). This means that anyone with a case against a newspaper that could have been heard in court, can have it arbitrated by a very senior lawyer at low cost – and the newspaper has to go along with it.

Our work also received endorsement in court. A judicial review brought against one of our rulings – the first since we started in 2014 – was dismissed on

all counts and the judgment was helpful in confirming our application of the Editors’ Code.

We have further developed our services and the areas we work in – producing new guidance and information for the public; stepping up our engagement with the public and with groups and people who have concerns about coverage of particular issues; as well as extending our training programme to support more journalists and students than ever before to produce high quality content.

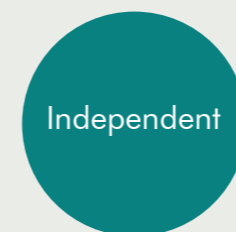
A highlight of 2018 was the launch of the IPSO mark, which our 1,500 print and 1,100 online titles can use to show they embrace high editorial standards, distinguishing themselves from the unregulated by demonstrating that they choose to hold themselves accountable.

Although the newspaper and magazine industry faces a number of complex challenges over the short term, I firmly believe that one of the ways in which it can thrive and prosper is by its commitment to independent, effective regulation. Looking to the future, 2019 has seen the renewal of publishers’ five year contracts, as we move into a second phase of regulating the press and protecting the public.

IPSO is the independent regulator of the vast majority of the UK’s newspaper and magazine industry. We hold newspapers and magazines to account for their actions, protect individual rights, uphold high standards of journalism and help to maintain freedom of expression for the press.

We will carry out our work free from control or interference by the press, Parliament, interest groups or individuals.



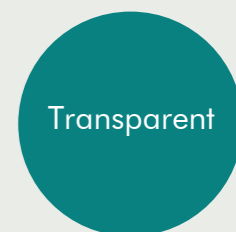
We will act without fear or favour.

# Guidance on the issues the public ask us about most

OUR INFORMATION helps the public to understand the rules which IPSO-regulated newspapers and magazines must follow, so they can be more confident in engaging with the press and know how IPSO can help if things go wrong.

We use knowledge and data from daily work with complaints, wide monitoring of the media landscape and engagement with groups interested in coverage of particular issues to help us produce our information, which has been awarded the Plain English Crystal Mark.

In 2018 we produced four pieces of guidance addressing topics which we receive lots of inquiries from the public about.

1 “Court reporting: What to expect” is for those who may be involved in court proceedings, including witnesses, people accused of a crime or the family of someone accused of a crime. It explains the importance of open justice and gives information about what to expect when the press is interested in reporting court cases, and how IPSO can help with any concerns.

2 “Reporting on a death” is for people who have suffered a recent loss of someone close to them. It explains what to expect when newspapers and magazines report a death or an inquest, as well as about how IPSO can help.

3 “Journalism and the use of information from social media” is for anyone concerned about how a newspaper or magazine can use information taken from social media, and gives advice about the rules which newspapers and magazines must follow as well as the support IPSO can offer.

4 “Information for survivors of sexual offences” explains what survivors should expect from journalists, empowering them to speak to the media should they wish to, and to know where to go for help if they do have any concerns.

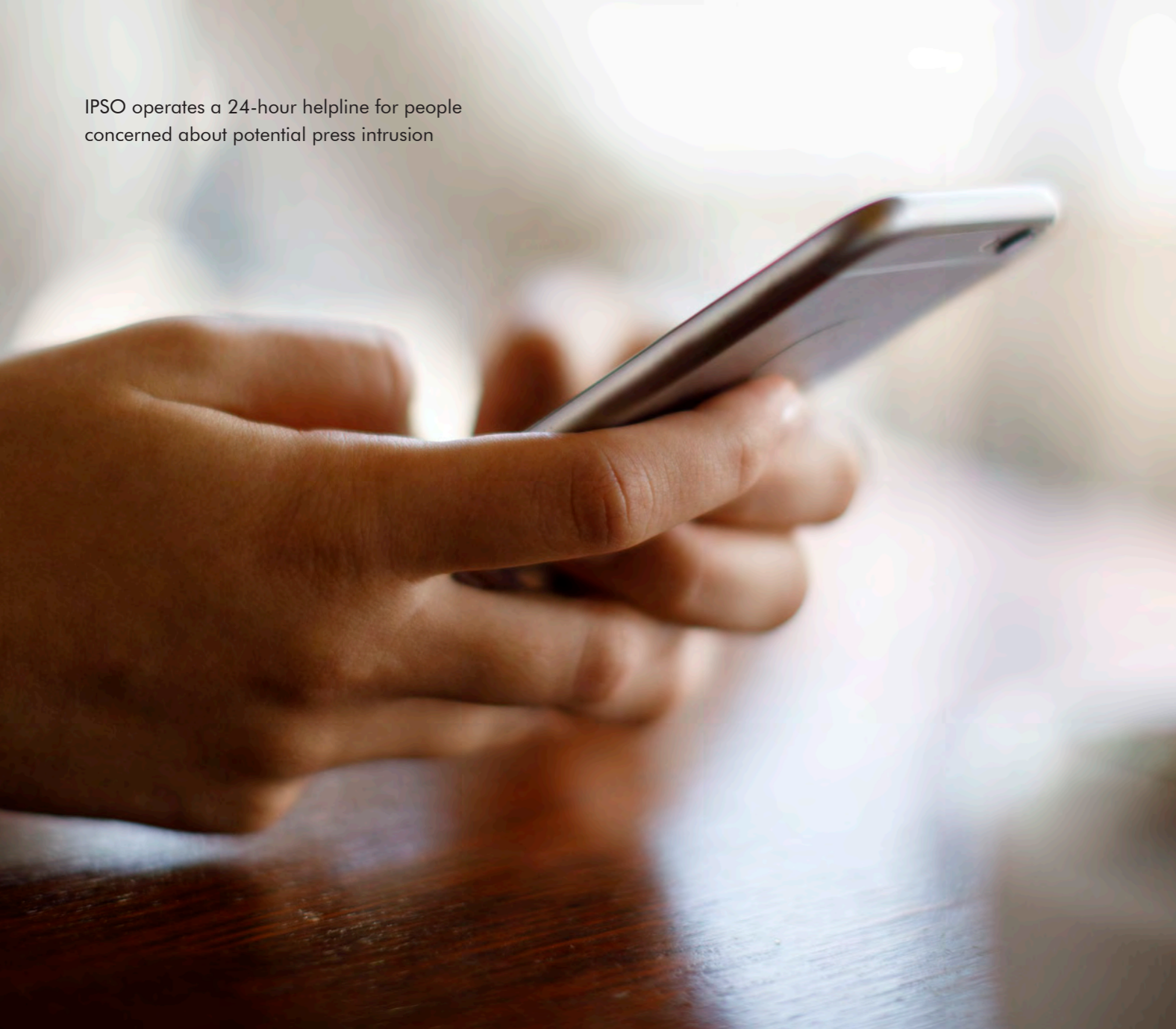
## Quality information to support survivors of sexual offences

We met with many survivors who talked about how sensitive media reporting of sexual offences helped them to speak about their own experiences and encouraged them to seek support. We wanted to help those who may come into contact with the media, whether they want to speak about their own experiences or not, by producing information for them.

We worked with organisations which provide support to survivors of sexual offences and domestic violence, including Rape Crisis, Solace Women’s Aid, LimeCulture and Women’s Aid. IPSO members of staff also met with survivors of sexual offences and domestic violence, as part of the Angles project being run by On Road Media.

# Supporting victims, families and agencies in major incident situations

THE OFFICIAL REPORT on the response to the Manchester attack, led by Lord Kerslake, was published in 2018. One of the issues raised in the report was the alleged experience of some victims' families with the media. While some outlets, like the Manchester Evening News, were singled out for praise, the report included accounts from families

and survivors who spoke about negative experiences with some parts of the media.

Reporting in the aftermath of a major incident like Manchester is incredibly challenging. There is a huge public interest in reporting on events and there is often a significant media presence. Journalists must

strike a difficult balance between reporting accurately and sympathetically on tragedies on the public's behalf, whilst also not intruding into individuals' grief or shock.

The Editors' Code requires journalists to approach bereaved family members with sympathy and discretion, to ensure their reports are accurate and to respect people's privacy and stop their approaches when asked to do so.

The Kerslake Review made a number of recommendations for agencies involved in responding to major incidents including two for IPSO: to review the provisions in the Editors' Code in relation to major incidents; and to work with other agencies to raise awareness of how we can support people affected by potential press intrusion.

IPSO took the recommendations extremely seriously and committed to a full action plan. We reviewed the Editors' Code and concluded that the existing provisions were already adequate to cover such events and that the concerns raised would already be covered by the existing Code.

We committed to taking forward any complaint about conduct by journalists working for, or commissioned by, an IPSO publisher, but in the absence of more detail, we could not investigate the examples in the report. We did uphold a complaint relating to coverage in the Daily Star which inaccurately identified an individual as being amongst the victims and ordered the newspaper to publish a full adjudication, the Complaints Committee's most serious sanction.

We also committed to raising awareness of how we can support people worried about potential press intrusion. This included developing guidance for editors and journalists and for the public based on the current Editors' Code covering reporting on major incidents and providing newsroom

training and resources, working with journalists and people affected.

We have proactively publicised our role and work, particularly our 24-hour harassment helpline and private advisory notices, to first responder organisations through their trade magazines and blogs. We have also attended a number of organisations' emergency training programmes to let them know about how we can provide support to people affected by media intrusion.

We are also providing further training to agencies such as the Police, Family Liaison Officers and other first responders around reporting of major incidents including how IPSO can offer help and support.

### ● IPSO PRIVATE ADVISORY NOTICES

#### Help with potential intrusion

In the vast majority of cases, journalists comply with the rules, but if someone has made it clear that they do not want to speak to reporters, we have a 24-hour harassment helpline to offer support to those who believe they are the subject of press intrusion.

We can provide advice and have the power to issue private advisory notices to the industry which make it clear that an individual does not want to speak to the press.

The notices are extremely effective as a tool to tackle media scrums or to prevent harassment. They can also pass on concerns about the potential publication of intrusive or private information or help people find space at a time of grief or shock. They make clear, for example, that those who have suffered a bereavement do not want to talk to the press.

# 3

QUALITY GUIDANCE AND TRAINING

## Supporting editors, journalists and publishers to produce trusted content

IPSO SUPPORTS editors and journalists to comply with their obligations under the Editors' Code with comprehensive guidance on a range of challenging and sensitive topics. In 2018 we produced three pieces of guidance to add to our growing suite of information: reporting on deaths and inquests, reporting on sexual offences and reporting on suicide.

Part of IPSO's regulatory role is to promote and uphold high standards in journalism. One of the ways in which we can do this is by connecting journalists and editors with different expertise, knowledge and groups, particularly around sensitive and difficult topics which can be challenging to report on.

An example of this in practice is the guidance we produced on reporting on suicide.



The way in which the UK media has reported suicide has changed fundamentally over the years – in part due to organisations working in the area of suicide prevention – but also due to a real recognition among editors and journalists of the impact of poor quality reporting on vulnerable individuals.

Our guidance on reporting suicide aims to improve editorial standards by helping journalists to understand how to cover this important and sensitive subject responsibly. Based on the Editors' Code, it outlines key questions to consider and includes a

number of useful case studies. It includes information on both the importance and risks of reporting suicide, sensitivity when reporting, and what may be considered excessive – and therefore potentially harmful – detail about methods of suicide.

The information was developed after discussions with journalists and organisations working in the area of suicide prevention, including Samaritans and PAPYRUS Prevention of Young Suicide. It also draws on lessons learned through IPSO's complaints and pre-publication services.

We supported the launch of this guidance by publishing a series of blogs co-authored with Samaritans covering in more detail the research around the reporting of suicide and key points for editors and journalists to consider, including around reporting on suicides in public places, inquests, self-harm, young suicides and suicide clusters.

### SUPPORTING QUALITY JOURNALISM

#### Bespoke newsroom training

Our broader commitment to press standards includes supporting all of our member publishers, large or small, with bespoke newsroom training.

In 2018 we visited publishers in newsrooms up and down the country.

Our training provides more information about IPSO, explains our complaints process, and how publishers can cooperate with this, including advice on how to resolve complaints. We also explain key decisions by the Complaints Committee, so that editors and journalists can understand how IPSO approaches difficult issues.

We can also offer specialised training, focusing on particular topics, or rulings that the publication thinks are interesting and relevant to their work.

# 4

## TRANSPARENT MONITORING AND SCRUTINY

### Gathering a rich body of evidence to monitor and understand editorial standards

WE USE knowledge and data from daily work with complaints, wide monitoring of the media landscape, and engagement with groups interested in coverage of particular issues to track patterns, identify areas of potential concern and provide targeted interventions to raise press standards. We monitor trends and, where necessary, take targeted action to address issues in a proportionate way, ideally at an early stage. This ongoing monitoring is vital to ensuring

that IPSO remains aware of any potential issues and is able to respond appropriately.

Our annual statement process, a key requirement under the terms of publishers' legally-binding contract with IPSO, is another important way of monitoring editorial standards. The statements are a public declaration of the steps taken by publications to meet journalistic standards. They clearly show the public how newspapers maintain and monitor editorial standards, how they respond to complaints, and the action they take to put things right when required. Importantly, publishers are required to explain how they have addressed any upheld complaints so that a similar breach does not occur again. 2018 annual statements can be viewed at [ipso.co.uk/monitoring](http://ipso.co.uk/monitoring)

## THE IPSO MARK

### Distinguishing newspapers and magazines in print and online as quality, trusted content

IN AN ERA where the public's trust in journalism has been undermined because of the rise of fake news and disinformation, the IPSO mark, which was launched in 2018, is a way that IPSO-regulated newspapers, magazines and websites can show their readers they embrace high editorial standards and public accountability.

The mark is a visual symbol that demonstrates a commitment to professional standards and an edited, regulated product and was launched alongside a national advertising campaign to raise awareness of both the mark and IPSO's work.

The mark is a way for publishers to communicate to readers that their content is regulated and helps

distinguish publications from the unregulated. All IPSO regulated publications are entitled to carry the mark and it now features in 66% of all our regulated titles, including in all national newspapers.

The mark supports the public in avoiding harmful fake news, and knowing how to identify curated and edited content displaying high-quality journalism. It also raises awareness of the methods available to seek redress from the regulated press when things do go wrong.

#### TACKLING FAKE NEWS

### A thriving, accountable news industry is part of the solution

We believe that media literacy is important. Readers should be confident that what they're reading is accurate. If they don't think it is, they should know how to challenge it.

All IPSO-regulated publishers follow an agreed set of standards – the Editors' Code – and have chosen to make themselves accountable to an independent regulator.

We want the public to be able to avoid harmful fake news and know how to identify curated and edited content displaying high-quality journalism. We would also like them to have increased awareness of the methods available to seek redress from the regulated press if journalists do get things wrong.

We believe that independent regulation has a key role to play in this, by holding publishers accountable to an external set of standards and helping consumers to easily identify edited, curated, professionally produced products.

If it's IPSO-regulated, readers can be sure that what they're reading in their newspaper or magazine is quality, accountable journalism.

# 6

## COMPULSORY ARBITRATION

### A cost-effective and straightforward method of resolving legal claims

SINCE 2016, IPSO has run a voluntary arbitration scheme for people who feel they have been wronged by newspapers so they can make legal claims against the press quickly, cheaply and effectively. In 2018, the scheme was made compulsory for national newspapers – which means a publication which is a member of the compulsory scheme has no choice but to arbitrate with anyone who has a valid legal claim. The compulsory scheme includes the seven best-selling national daily newspapers and eight best-selling Sunday newspapers: The Daily Telegraph, The Sunday Telegraph, Daily Mail, Mail on Sunday, Metro, The Times, The Sunday Times, The Sun, The

Sun on Sunday, Daily Express, Sunday Express, Daily Star, Daily Mirror, Sunday Mirror, and Sunday People.

Complaints and enquiries received by IPSO in 2018

IPSO was established in September 2014, since then we have dealt with over 47,000 complaints and enquiries from the public.

IPSO'S COMPLAINTS process supports those who feel wronged by the press and provides them with means of redress if the Editors' Code has been breached.

In 2018 we received over 8,000 complaints and enquiries. All these were expertly assessed to determine whether the complaint fell within IPSO's remit and raised a possible breach of the Code.

COMPLAINANT FEEDBACK

507 cases were taken forward for investigation. Each case is assigned to a named Complaints Officer, who provides guidance and assists the process of mediation, before a complaint is ruled upon. All rulings are published on our website.

Complaints that are not taken forward are still an important part of our wider press standards monitoring. We may receive a large number of complaints that relate to a specific subject of coverage, or complaints that raise issues about particular ways in which news is gathered. Even where a complaint cannot be taken forward, for example because it has been made by a third party, it is valuable for IPSO to know that it is of concern to the public, particularly where there is a pattern of similar complaints.

# Most complained about articles.

National newspapers with highest circulations and readerships received the most complaints in 2018.

THE PUBLICATIONS in this list are ranked by number of articles complained about. Unsurprisingly, the publications with the highest circulation and readerships received the most complaints. Interestingly though, considering the large amount of content produced by these newspapers on a daily basis, the number of articles complained about are comparatively low.

Where complaints are listed as rejected, they did not raise a possible breach of the Editors' Code. Some of the publications received many complaints, but were not in breach. We were also pleased to see an increase in resolutions between publication and complainant, meaning that the complaint was settled by both parties to the satisfaction of the complainant.

## CASE STUDIES

### Sam Allardyce The Daily Telegraph

#### "Football for sale" undercover investigation in the public interest

SAM ALLARDYCE and others complained about 15 articles relating to an undercover investigation by The Daily Telegraph which included details about the then-England manager's commercial interests. They said that using subterfuge to obtain this information was unjustified and the articles contained a number of inaccuracies. The Telegraph said it had been essential to use subterfuge to carry out its investigation into English football which was clearly of significant

public interest and that its coverage was accurate. IPSO's Complaints Committee said it was satisfied that the level of subterfuge used was proportionate to the public interest, but partly upheld the complaint on three points of accuracy – one in a news item and two in subsequent comment pieces – which represented a breach of Clause 1 and required correction, which it ordered should be published on page 2 of the newspaper and online.

#### Front page reference required after inaccurate report

ANTHONY FLETCHER complained that The Daily Record breached Clause 1 (Accuracy) in a story which reported he was illegally trading sperm donations and had admitted to fathering 22 children. He said the publication had misinterpreted the law because he was not procuring or distributing sperm as a third party without a licence and that it was inaccurate to report he had "admitted" to acting illegally. He said the reference to "black market" further implied his actions were illegal.

The publication said the original copy was provided by an agency which had referred to the Human Fertilisation and Embryology Act 1990 as the basis for claiming the donor had acted illegally, and was published in good faith. They denied that using

the term "black market" implied illegality. IPSO's Complaints Committee upheld the complaint.

The publication accepted that it was inaccurate to report that the complainant's actions were illegal and said this was an error based on a misreading of publicly-available information. Used in the context of an article which had alleged illegality, use of the term "black market" carried a strong implication that the complainant's conduct was outside the law, which was inaccurate.

The Daily Record was ordered to publish the Committee's full adjudication on page 10, with a reference on the front page as the story had originally appeared on the front page and on page 10.



## Tower Hamlets Council The Times

Article about child placed in Muslim foster home created distorted impression of judge's ruling. Full adjudication ordered to rectify inaccuracies

TOWER HAMLETS Borough Council complained that The Times breached Clause 1 (Accuracy) in an article headlined "Judge rules child must leave muslim foster home". The article under complaint formed part of the newspaper's coverage of a child's fostering arrangements. Tower Hamlets Council said it created a distorted impression of its position in legal proceedings related to the child's welfare.

The Times denied the inaccuracies and said there was a public interest in the story because of fears that foster care in Britain was not placing children with carers who share their ethnic and cultural heritage and provided further evidence that Tower Hamlets

was a borough in which vulnerable children were at risk, as reflected by a critical Ofsted report in 2017.

IPSO's Complaints Committee ruled that the article gave the overall impression that the judge had found that the placement was a "failure" by the Council and that this was why she was "removing" the child from her current foster carers and placing the child with the grandmother. This represented a distortion and it ordered that a full adjudication should be published on page 6 or further forward. The Times published the adjudication on page 2 and chose to highlight the Committee's ruling with a front-page reference.

## A woman Dover Express

Exceptional public interest in article on children's serious case review

A CUSTODIAL guardian complained that an article about a serious case review intruded into four children's welfare and privacy. The report named the children's deceased sibling and their mother when identifying a number of times that services had failed to intervene to protect the children. Their guardian said this made them identifiable.

The newspaper said it had taken steps to protect the children's identities by removing details included in the safeguarding report, but that the information was well-known within the local community. It said there was a strong public interest in scrutinising publicly funded social services, particularly in relation to serious mistakes and potential improvements, and that this could only be achieved by including relevant information to highlight the scale of the errors

covered in the serious case review. It also noted there were no reporting restrictions in place.

IPSO's Complaints Committee said the article included highly sensitive information about the four children on whose behalf the complaint had been made and had the potential to be intrusive. By naming the children's mother and the child who had died, the woman's remaining children were identifiable as the subjects of the review. Therefore, an exceptional public interest was required to justify publication of this material. The Committee ruled that because of the gravity of the alleged failings, there was a need to detail concerns of serious neglect within the family which the authorities had failed to act upon. The complaint was not upheld.

## Shoaib Khan Daily Mail

Complaint upheld despite published corrections. Front page reference ordered to correct inaccuracies

SHOAIB KHAN complained about a Daily Mail article reporting on a High Court judgment awarding compensation to an Iraqi citizen for unlawful imprisonment, which included the sub-headline "Iraqi 'caught red-handed' with bomb". He said that the article was inaccurate on a number of points, including that it had not made clear that the claim in the sub-headline had been found by the court to be inaccurate.

The newspaper said that British soldiers had claimed that they had found the defendant handling a bomb and were entitled to report such claims, which they had made clear was speculation by use of inverted

commas. It had previously published two separate corrections relating to the story but the complainant said these were not prominent enough and asked IPSO's Complaints Committee to rule on the complaint.

IPSO upheld the complaint, as neither on the front page, nor in the main body of the article, was it explained that the claim that the defendant had been caught with a bomb had been discredited. The Committee found that given the nature of the breach, a front-page reference and adjudication was required to rectify the inaccuracies.

## MacPartlin & Corbett Woman magazine

Report on public's pregnancy speculation did not breach privacy

ANT MACPARTLIN and Anne Marie Corbett complained that an article in Woman, which speculated Ms Corbett might be pregnant, breached their privacy. They said that Ms Corbett was a private individual and that this was a deeply personal matter. They accepted that there had been some speculation about a possible pregnancy by the public on social media but said the publication had adopted this as fact and amplified it.

Woman magazine accepted that the reporting of speculation could, in certain circumstances, constitute a breach of privacy, but said it was not the case in this instance, as the article had clearly reported a possible pregnancy as the conjecture of others. The publication stressed that it was entitled to discuss and report on the lives of people of interest to readers.

IPSO's Complaints Committee emphasised an individual may have a reasonable expectation of privacy about a pregnancy, especially during the early months and acknowledged that publication of speculation may, in and of itself, be intrusive, depending on the full circumstances.

However, in this instance, the publication had demonstrated that around the time the article was published, photographs had given rise to widespread speculation as to whether the couple were expecting. It had not expressed a view on the credibility of these claims nor had it added details to or endorsed the views. In these circumstances, the article was not a breach of privacy and the complaint was not upheld.

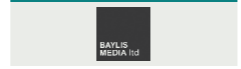

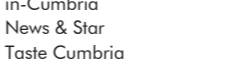
